From time to time, you may need to use our railcars for a longer period of time. In that case we provide you, at your option, with the use of that equipment, for a fee.

### **Extended use of railway provided assets**

We give you free time for loading and unloading cars. If you choose to keep a railroad car, or a private car on railroad property, for additional time, you will be billed a simple flat daily fee. Daily charges do not apply to non-chargeable days, as defined in the Central Region General Tariff 1000 Section III, Demurrage and Storage Provisions, Page 22, Item 3090.

#### Free time on the DGNO will be computed from the first 1000 after the car is tendered.
