Switching cars by the ETRY from or to points of interchange when freight originates or is destined to the stations beyond the operating limits of ETRY. The ETRY will switch traffic between industries located on ETRY and interchange points at the charges listed below:

ETRY will switch traffic between the CSXT and NS at a charge of \$746 per car.

The switching charge contained in this tariff cover the movement of loaded or partially loaded cars one way and the return of the same car empty, or the placing of any empty car and the return of the same car loaded or partially loaded. Any empty given to ETRY by CSXT where ETRY does not get a loaded movement (i.e. overhead empty moves) will incur the \$746 charge.
