Flexible Asset Utilization...

The effective management of railcars is critical to the success of MNA and our customers. Efficient asset utilization benefits you by increasing the availability of railcars.

From time to time, you may need to use our railcars for a longer period of time. In that case we provide you, at your option, with the use of that equipment, for a fee.

Extended use of railway provided assets

We give you free time for loading and unloading cars. If you choose to keep a railroad car, or a private car on railroad property, for additional time, you will be billed a simple flat daily fee.

Saturdays, Sundays, and Holidays will be considered non-chargeable when the car has been tendered within 24 hours before the Saturday, Sunday, or Holiday. If the free time on the car is already expired and customer is in chargeable days, then all subsequent Saturdays, Sundays and Holidays are chargeable. A Saturday, Sunday or Holiday cannot be the first chargeable day. Non-chargeable days are defined in the Central Region General Tariff 1000 Section III, Demurrage and Storage Provisions, Page 22, Item 3090

Billing Disputes

We commit to addressing disputed bills quickly

If you believe that there has been a billing error, we want to make it right as quickly as possible.

To be eligible for a review, a claim must be submitted, in writing, within 30 days of the invoice date to:

Along with a brief description, your claim must include the car initial and number and the related invoice number.

Any claim not filed within thirty (30) days from the date of the invoice will be declined.

Any non-disputed charges should be paid by the due date listed on the respective invoice.



Flexible Car Ordering...

Things don't always go as planned. We recognize that, sometimes, you will have to change your railcar order for loading or unloading. When this involves ordering an empty railcar for loading and actual or constructive placement is performed, and the railcar is then released without being loaded, it is classified as a *railcar ordered but not used*.
