PUBLIC SWITCHING RATE WAIVER MVRV SW 8000-1
CUSTOMER: ALL MVRV CUSTOMERS

EFFECTIVE: September 1, 2023

EXPIRES: April 30, 2024

RATE: \$600 Per Car for outbound switch (includes cherry picking that will apply on every car)

EQUIPMENT: See Appendix A

NOTES:

- Switching Charges are NOT subject to a Fuel Surcharge.
- Covers combined rates for outbound switch rates to car owners who have requested cars to move off MVRV.

GENERAL RULES

This will serve as a switching rate waiver (the “Waiver”) by the The Mahoning Valley Railway Company (“RAILROAD”) for the benefit of All Railroad Customers (“Customer”) and covers a reduction in the rate for outbound switching.

Any switching charges from connecting roads will be in addition to those of the Railroad.

This Waiver shall become binding on the parties upon acceptance by the Customer. Customer may accept the terms and conditions of this Waiver either by written notice to Railroad, or by the tender of rail cars for the switching services in accordance with the terms herein.

Additionally, it is acknowledged and agreed to by the parties that except for the rate set forth herein, the switch services described in this Waiver as well as any services not covered by this Waiver, are subject to the rules and provisions of The General Tariff 70067-series, as such tariffs may be amended, supplemented, modified or superseded from time to time.

Except when in conflict with the other provision of this Waiver, shipments of Commodity(ies) tendered for transportation hereunder shall be governed by tariffs, exempt circulars, rules, regulations, classifications, that would govern the rights and obligations of the parties if this Waiver did not exist, except that no diversion, reconsignment or transit privileges will be permitted.

This Waiver can be cancelled by either party upon 30 days written notice and tariff terms and rates shall apply to all switching performed by Railroad thereafter.

Customer shall not disclose either the existence or terms of this Waiver to any third party without the written consent of Railroad.

LOSS OR DAMAGE

No claim for physical loss or damage to any one shipment transported hereunder shall be made or filed by Customer for amounts of \$250.00 or less. Any claims should be filed with the destination Carrier.
