We give you free time for loading and unloading cars. If you choose to keep a railroad car, or a private car on railroad property, for additional time, you will be billed a simple flat daily fee. Daily charges do not apply to non-chargeable days, as defined in the General Tariff 1000 Section III, Demurrage and Storage Provisions, Page 22, Item 3090.
