Freight Tariff RCPE 9002-1

NAMING FUEL SURCHARGES ON LOCAL, PROPORTIONAL AND JOINT LINE RATES FOR RAPID CITY, PIERRE & EASTERN RAILROAD

APPLICATION: This publication applies to: (1) all regulated common carrier linehaul freight rates existing or established by RCPE on or after June 1, 2014; and (2) all linehaul freight rates and charges with respect to exempt traffic, and linehaul freight rates and charges in contracts, private price quotations or other pricing documents, that both reference this publication and are entered into or issued and effective on or after June 1, 2014.

In the event that the monthly average price per gallon of highway diesel fuel (as determined below, the "HDF Average Price") equals or exceeds 326.0 cents, RCPE will apply a mileage-based fuel surcharge to the linehaul rates and charges described above. The fuel surcharge will be applied to each qualifying shipment having a bill of lading or other shipping instruction dated on or after the first day of the second calendar month following the calendar month of a given HDF Average Price determination (e.g., a fuel surcharge applied beginning December 1 would be based on October's HDF average price).

The "HDF Average Price" for a month will be the average price for that month of U.S. No. 2 Diesel Retail Sales by All Sellers, as determined and published by the U. S. Department of Energy, Energy Information Administration ("DOE-EIA") The referenced DOE-EIA publication can currently be found at www.eia.doe.gov. That average price will, in calculating the HDF Average Price, be rounded to the nearest 1/10th of a cent applying conventional rounding principles. If DOE-EIA ceases publication of the above information, RCPE will employ a suitable substitute source of price or measure.

The mileage to be applied in calculating the fuel surcharge will be based on PC*Miler Rail from ALK Technologies. If interline routing is involved, mileages will be calculated via the revenue route junction(s) of the price used to rate the shipment.

Should the cost of fuel increase beyond the above matrix, the increase will be \$.01 per mile for each \$.04 increase in the DOE fuel price index.
