### GENERAL RULES

• This Confidential Exempt Railroad Quotation(the "Quotation" or "Agreement")shall become binding on the parties upon acceptance by the Customer named above. Customer may accept the terms & conditions of this Agreement either by written notice to Toledo, Peoria & Western Railway Corp ("TPW") or by tender of traffic under its terms.

• Additionally, it is acknowledged and agreed to by the parties that any services not covered by this Agreement are subject to the rules and provisions of the General Tariff 70067-series Charge Catalog for the TPW, as such tariffs may be amended, supplemented, modified, or superseded from time to time.

• Except when in conflict with the other provisions of this Quotation, shipments of Commodity(ies) tendered for transportation hereunder shall be governed by tariffs, exempt circulars, rules, regulations, and classifications, as each may be amended, supplemented, modified, or superseded from time to time, that would govern the rights and obligations of the parties if this Quotation did not exist, except that no diversion, reconsignment or transit privileges will be permitted. Each shipment hereunder shall be tendered to Carriers on a Uniform Straight Bill of Lading. TPW Quote number (located on Page 1) must be shown on all bills of lading tendered for shipment.

• This Quotation can be cancelled upon 20 days' notice and tariff terms and rates shall apply to all traffic received by TPW thereafter, as such tariffs may be amended, superseded from time to time. Reverse application applies only on rejected shipments returning to point of origin via reverse route. Except when specifically provided herein, rates do not include switching charges at origin or destination.

• Customer shall not disclose either the existence or terms of this Quotation to any third party without the written consent of the Railroad.

### LOSS OR DAMAGE

• In addition to all limitations provided for in The General Tariff 70067-series, no claim for physical loss or damage to any one shipment transported hereunder shall be made or filed by Customer for amounts of \$250.00 or less. Any claims should be filed with the destination Carrier.

## **General Conditions**

#### Description

Mileage allowance payments will not apply.

Price must be used in combination with other prices for the portion of the shipment both prior to specified origin and subsequent to specified destination. Separate freight bills will be issued for each price used according to the provisions of Railway Accounting Rule 11 for the portion of the shipment both prior to specified origin and subsequent to specified destination.
