APPLICATION: This publication applies to: (1) all regulated common carrier linehaul freight rates existing or established on or after April 1, 2018 and (2) all linehaul freight rates and charges with respect to exempt traffic, and linehaul freight rates and charges in contracts. Private price quotations or other pricing document that both reference this publication and are entered into or issued and effective on or after April 1, 2018.

In the event the average price per gallon of highway diesel fuel (as determined below. the “HDF Average Price”) equal or exceeds \$2.30 per gallon, the mileage-based fuel surcharge will apply to the linehaul rates and charges described above. The fuel surcharge shall be applied to applicable shipments beginning the second month following the month the HDF average price calculation was based. (e.g. a fuel surcharge applied beginning December 1 would be based on October’s HDF average price).

The HDF Average Price for a given calendar month will be determined by recording the monthly average Retail On-Highway Diesel Fuel price posted on the U.S. Department of Energy Web site (eia.doe.gov). The result will be rounded to the nearest ten-thousandths of a cent. If the Department of Energy ceases reporting of the price of Retail On-Highway Diesel Fuel, a suitable substitute source of price or measure will be named. Schedule reflects the applicable fuel surcharges within the HDF Average Price ranges noted in the table below.

For each \$0.025 per gallon increase thereafter apply an additional \$0.00575 per mile for Bulk commodities, and \$0.0060 per mile for all other Carload commodities.

For customers who are invoiced in Canadian dollars, the U.S. On-Highway Diesel “HDF” surcharge will be converted to Canadian currency. The exchange rate is based on the Bank of Canada monthly average rate of exchange for U.S. funds. For example, the fuel surcharge in October will be based on the U.S. On-Highway Diesel “HDF” and will be multiplied by the Canadian exchange rate for August.
