**Flexible Asset Utilization...**

The effective management of railcars is critical to the success of YB and our customers. Efficient asset utilization benefits you by increasing the availability of railcars.

From time to time, you may need to use our railcars for a longer period of time. In that case we provide you, at your option, with the use of that equipment, for a fee.

**Extended use of railway provided assets**

We give you free time for loading and unloading cars. If you choose to keep a railroad car, or a private car on railroad property, for additional time, you will be billed a simple flat daily fee. Daily charges apply as defined in the Ohio Valley Region General Tariff 1000 Section III, Demurrage and Storage Provisions, Page 22, Item 3090.

## **Flexible Car Ordering...**

Things don't always go as planned. We recognize that, sometimes, you will have to change your railcar order for loading or unloading. When this involves ordering an empty railcar for loading and actual or constructive placement is performed, and the railcar is then released without being loaded, it is classified as a *railcar ordered but not used*.
